Co-existence of company members and association members (national and global associations) ensures highest level of competence and know-how.



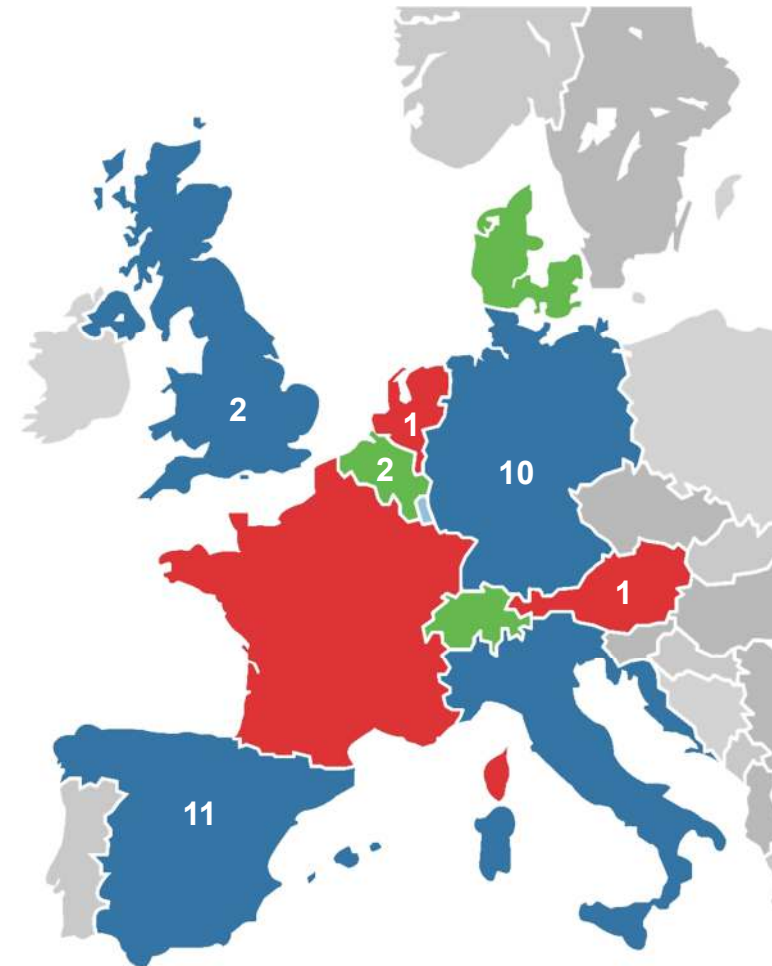
