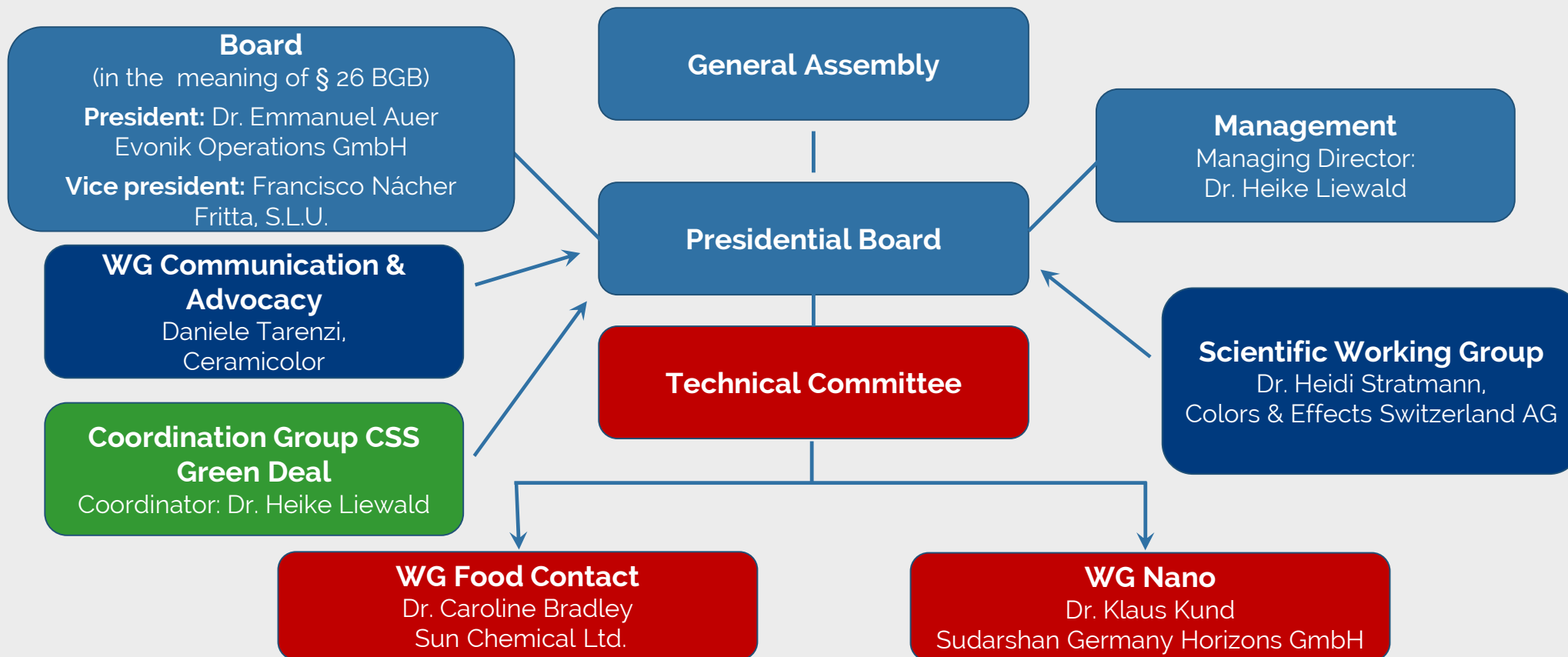
- Single voice and image promotion for the European colourant industry
